Information for Applicants

The Renewal Trust is an organisation with the following objectives:-

- 1) To improve the social and living conditions in the Renewal Trust area and enhance community safety, confidence and health.
- 2) To attract funding and investment into The Renewal Trust area in order to stimulate, promote and continue economic regeneration.
- 3) To encourage and empower local people to become involved with The Renewal Trust and take responsibility for the development of their own communities.

Our Community Grant fund helps local Voluntary and Community Groups get projects and events up and running in the St Ann's, Sneinton and Mapperley (within Nottingham City).

Below you will find details of how the fund operates. Please contact us if you need further information.

- Grants will only be given to Community/Voluntary organisations in The Renewal Trust area. The Renewal Trust will only fund CIC's where governance is clear that individuals will not benefit.
- Community Grants will be agreed by a panel of three members. Applications must be submitted by 15th of each month.
- Applications will only be accepted on an application form.
- Eligibility - Grants can be awarded to new and existing schemes which:
 - Are run by voluntary organisations and community groups operating within The Renewal Trust area.
 - Meet at least one of The Renewal Trust's objectives.
 - Can show local support and involvement in their work.
 - Can evidence the need for the project.
- Grants for projects/events involving children and young people will only be awarded to groups who can show they have considered Safeguarding Children and Young People and as a minimum subject all volunteers, employed workers to Enhanced Disclosure and Barring Service checks.
- All events and publications must display The Renewal Trust logo if supported by a Community Grant. (These will be sent to you once your application has been successful).
- Grants cannot be used for salaries or wages.
- If the grant is for learning purposes and you have stated a teacher or tutor will be involved, evidence of their qualifications will need to be provided.
- The decision of the Panel is final and there is no appeal process.
- You will need to complete a Community Grant Feedback form, evaluating the project along with a breakdown of how the grant was spent and the difference it made. This should be completed within four weeks of the project completion/grant expenditure. Please include at least one photo with the form, which could be used on our website and through our social media platforms. Any photos provided must have consent.

Maximum Grant

Grants are available up to a maximum of £500 for any one project in any **12 month period**.

Payment of Grant

Applications must be submitted with details of the organisations bank account. Payment **cannot** be made to individuals.
